## **1. Team Composition:**

A Team from the National Commission for Protection of Child Rights (NCPCR), led by its Member Dr. Yogesh Dube visited Allahabad from 23rd – 26th April 2012. Dr. Dube, who is also the Chairman, Core Committee on Child Rights in Uttar Pradesh, was accompanied by two Senior Consultants of the Commission (Ms. Shaista Khan & Dr. Ramanath Nayak) in this visit to the State.

The NCPCR Team also included the complainant (Ms. Vinika Karoli, State Coordinator, Quality Institutional Care and Alternative for Children in Uttar Pradesh) in the investigation of Children Homes.

## **2. Background and Purpose of the Visit:**

National Commission for Protection of Child Rights received a complaint from Ms. Vinika Karoli, State Coordinator, Quality Institutional Care and Alternative for Children in Uttar Pradesh (QICACUP) regarding news item published in all the leading newspapers of Uttar Pradesh with regard to sexual abuse of children in Shishu Grih (Care and Protection Home) Allahabad. The Commission took cognizance of the matter and a letter in this regard was sent to the Chief Secretary, Government of Uttar Pradesh and copies marked to Principal Secretary, Department of Women and Child Development, Uttar Pradesh, District Magistrate, Allahabad and Child Welfare Committee, Allahabad (**Annexure -1**).

The Commission came to know that *suo motu* in the matter has already been taken by the Allahabad High Court. It was felt by the Commission to make its own observation and assess the situation of the said Home along with other Homes in Allahabad. Accordingly, the Commission constituted a team comprising of Dr. Yogesh Dube (Member, NCPCR), Ms. Shaista Khan (Senior Consultant, NCPCR) and Dr. Ramanath Nayak (Senior Consultant, NCPCR). The Commission also felt the necessity of including the complainant, Ms. Vinika Karoli, State Coordinator, Quality Institutional Care and Alternative for Children in Uttar Pradesh, in the team.

### **3. Schedule of the Team:**

The team led by Dr. Yogesh Dube, Member, NCPCR visited the following homes for children in need of care and protection and children in conflict with law with District Probation Officer and Assistant Labour Commissioner, Allahabad.

These were:

- (1) Rajkiya Bal Grih Shishu, Shivkuti;
- (2) Rajkiya Baal Grih (Balika), Mamfordganj;
- (3) Rajkiya Sampreshan Grih (Kishore) Home for children (Boys) in conflict with law), Khuldabad; and
- (4) Rajkiya Mahila Sharnalaya (Home for children (girls) in conflict with law), Khuldabad

### **4. VISIT TO VARIOUS HOMES & OBSERVATIONS:**

#### **(1) Rajkiya Bal Grih Shishu, Shivkuti:**

The team led by Dr. Yogesh Dube, Member, NCPCR visited the Home where case of sexual abuse of girls by its Chaprasi (peon) was reported. The team inspected the Home and interacted with children and staff over there. This is a Home for the children between 0-10 years. After the children attain 10 years they are shifted to another Home (Rajkiya Baal Grih (Balika), Mamfordganj). The Home has been running in a rented building (on a rent of Rs. 19 thousand per month), which abodes total 31 children, including six (6) children from Adoption Center. Among these 31 children, 10 children were found to be suffering from malnutrition, HIV positive and with special needs (blind and mentally retarded). The team was told that the incidence came up on 5<sup>th</sup> April 2012. Accordingly FIR was lodged in the matter of sexual abuse of 4 girls by the Chaukidar of the Home. This led to arrest of 4 persons and suspension of 11 persons.

On interaction with the Superintendent and other staff in the Home, the team came to know that all the staff in position in the Home were new, as all the old staff of the Home were either suspended or transferred to other Homes. The Home still has three vacant positions. The found the Home very clean and all the 4 beds were covered with brand new bed sheets. However, none of the staff present were able to respond to any query by the team. Only answer received were “we are new and yet to get hold of the documents”. There was no open space available in the Home where children can play.

## **(2) Rajkiya Baal Grih (Balika), Mamfordganj:**

After Rajkiya Bal Grih Shish, Shivkuti, the NCPCR team visited the Balika Grih in Mamfordganj. The Balika Grih has been running in rented building. The team inspected the Home and interacted with the children. The women members of the team interacted with the victim girls. While interacting with the girls the team observed that they were



still in the stage of trauma. No efforts were made to provide counseling to them. None of the 10 children with special needs were attending the classes because of lack of specially trained teachers. These girls were sitting separately in a group and were engaged in some games. It was observed that the rooms were inadequate to house 41 girls. Currently one girl is attending the class in Hemvati Nandini Bahuguna College and few girls are enrolled in class 8-12 in Umrao Singh Inter-College.

The Home (Balika Grih) has tailoring vocation, but no teacher for the same. As a result a teacher has been additionally looking after. The Balika Grih has total 20 staff, including 6 teachers, who teach class I to V. The male night watchman guards from outside the building.

**(3) Rajkiya Sampreshan Grih (Kishore) Home for children(Boys) in conflict with law), Khuldabad:**

The team visited Sampreshan Grih, a home for children (Boys) in conflict with Law. The team found from its register that there were total 59 boys of below 18 years of age are being kept in this home. Although it was reported that all the boys are of below 18 years of age but team identified boys above 18 also. Member, Dr. Yogesh



Dube interacted with the boys and it was narrated by some boys that they washed utensils, clean floors and made to wash clothes. Eating area and kitchen was found filthy and unhygienic. The building of the home is newly constructed but no open place for play was found.

The home has total 21 staff including 4 teachers. The home is meant for the children in conflict with law of four districts, that is, Allahabad, Fatehpur, Pratapgarh and Kausambi. The children stated that the food is ok and adequate but they themselves have to prepare as there is no cook. They don't have any other activities to pass the time except watching television and some are engaged in canning of the chairs. The room where they are putting up is without an air cooler and the fans are running very slow.

**(4) Rajkiya Mahila Sharnalaya(Home for children(girls) in conflict with law), Khuldabad:**

The team subsequently visited the home for girls in conflict with law. At present there are 18 girls (including 5 abandoned and 13 booked under IPC/ITP Act) staying which reported to be less than 18 years of age but it was observed by the team that most of the girls are of above 18 years of age. The capacity of the home is for 25 girls. The team members

interacted with the girls. It was reported by the girls that they are above 18 years of age and wants to go back to their home but their parents are not willing to accept them or take back. There was only one bathroom and two toilets which are being shared by 18 girls. It was also informed to the team that among 18 girls, three of them are pregnant. When asked about their nutrition and diet, the duty nurse informed that protein diet is being given to them as prescribed by the doctor. Files and records were also checked by the team.

The NCPDR team recommended for proper age verification of the girls staying in the home. It was brought to the notice that only pregnancy test is done while admitting and no other test is done. Since there is no After Care Home at Allahabad, the girls above 18 are referred to the After Care Home at Varanasi and Lucknow.

### **5. Meeting with the Representatives of Civil Societies:**

A meeting with the members of Civil Society Organizations for child rights in Allahabad was taken by Dr. Yogesh Dube, Member, NCPDR along with other team members of NCPDR and Officials of Labour Department (List of participants is at **Annexure 2**).

It was shared by the NGOs that Shankargarh area of Allahabad is reported to be one of the main area of labours working in stone crushing and child labour has been reported in large number. This region seriously lacked primary education, health and Anganwadi services. There are 46 villages which are known as 'Raj Sankargarh', particularly the Hadai, Shidi, Gobra, Sunhari, Pervedbad, etc. villages, is full of quarries and each quarry having on average five to six thousand workers. It was brought to the notice that the quarry workers do not have any union, they are denied minimum wage, provident fund, medical facilities, which is giving rise to child labour, who are available cheaply. The region is about 50 km from the district headquarters and the field level staffers stay in the town and hardly visit. Accident and casualties are reported often because of blast and no safety measures are ensured as stoner crusinh is supposed to be looked after by the Central Labour Department. The quarries hardly maintain any register. While the

permission for stone quarry is given by the State Government the extraction of silica is the responsibility of the Central Government. As most of the quarries are illegal, it is causing huge loss of revenue to the Government.

Majority quarry workers are migrant families from Madhya Pradesh, Chhattisgarh and Jharkhand. The Labour Department was told to make Action Plan and conduct a detailed study on Shankargarh area.

## **6. Meeting with the District Officials:**

The NCPCR team had a meeting with all the concerned officials of District (under the leadership of Chief Development Officer) on 25.04.2012 at 5.00pm in the Circuit House of Allahabad. The meeting was chaired by Dr. Yogesh Dube, Member, NCPCR (List of participants is attached at **Annexure-3**).

The meeting started with brief on Rajkiya Shishu Grih, Allahabad. It was shared in the meeting by Circle Officer that cognizance in the matter has been taken by the Hon'ble High Court, Allahabad and two Committees have been constituted to conduct a detailed enquiry.

It was shared by Dr. Yogesh Dube, Member that children suffering with physical and mental disabilities and HIV positive were found in pathetic condition. The Chief Medical Officer was ordered to appoint nurse in these two homes for these children.

Members of Child Welfare Committee were asked to share their experience.

Assistant Labour Commissioner was asked to conduct survey on child labourers in Shankargarh in stone crushing mines and in Bidi making.

The Chief Medical Officer was asked to open Nutrition Centre for Children and get a detailed survey done of malnourished children in the District mainly in Shankargarh area. The region is reported 35% children affected by grade-III malnutrition and 0.7% children with grade IV.



## **7. Recommendations:**

Based on the observation made during the visit to various homes of Allahabad, the Commission directed the District administration/ Departments/ Authorities to initiate immediate actions on the issues and concerns listed below in order to ensure the rights and entitlements of the children:

### **Children Homes:**

- 1) Ensure better facilities and sanitation in all children homes, whether having its own building or in rented building;
- 2) Make available specially trained teachers for handling the differently-abled children, particularly the mentally retarded. Special arrangement may be made for the special needy children with special medical facilities, special Education;
- 3) Ensure a regular Staff Nurse, routine visit of doctors, monitoring by the Chief Medical Officer, regular health check up of the children with the facilities of health card for every child in every home;
- 4) Extending special care for the malnourished children in each home;
- 5) Provision of Counselor in every children home;
- 6) Appoint teachers for the only available vocational course, i.e., the tailoring;
- 7) Engagement of cooks in every home, so as to ensure that no children are asked to do cooking and washing the dish;
- 8) Filling up the sanctioned vacancies in all homes on priority basis and orientation immediately after their induction;
- 9) Make available the coolers, fans, bulbs and other basic necessities in the homes;
- 10) Age verification of the women placed in the Rajkiya Mahila Sharanalaya, Khuldabad may be undertaken on priority basis by an external agency comprising of a team of doctors of the Medical College;
- 11) Routine immunization must be carried out in the homes, particularly where children below the age group of 10 are staying;
- 12) Ensure special nutrition for the pregnant women placed in the sharanalaya as prescribed by the doctors;
- 13) Ensure that the chain of the children home staff is broken and are transferred to different homes on routine basis;
- 14) The Government Homes for children (girls) should have no male staff, even for night duty;

- 15) Victim girls should be counseled by members of Child Welfare Committee;
- 16) Member of CWC should make inspection to these homes in every fortnight and report to the District Probation Officer. DPO should also visit occasionally to cross verify the same;
- 17) Ensure Training Programmes for the officers and staff dealing with child rights issues and working in Children Homes;
- 18) Ensure filling of vacant post of Superintendents in all the homes on priority basis;
- 19) Health Department shall take prompt action in filling the vacant posts of Medical staff in homes;
- 20) There shall be Jan Sunvai at the children homes with the WCD department and NGOs to understand the problems of the children, with the provision of follow up in every six months.

### **Child Labour:**

- 21) Initiate immediate action to identify, rescue and rehabilitate the child labour in the District and particularly in the mining and quarries of Shankargarh to make it is a child labour-free block. As discussed with Chief Development Officer of the District, education facilities must be made available to the rescued children;
- 22) Child labour survey of the District must be completed on priority basis and action plan is prepared to develop the District as a Model Child Labour-free District;

### **Education:**

- 23) Education Department should undertake mapping of the drop-out students in the District and efforts are made to enroll them in their age appropriate classes through special coaching;
- 24) Special cluster school and NCLP school must be provided on-site in the sites of mining, quarries and brick kilns;
- 25) Ensure distribution of Mid-Day Meal and its quality as per the norms. Safe drinking water facilities, separate toilet for boys and girls must be made available in each and every school of the District;

### **District Administration:**

- 26) Initiate Village Sanitation drive and activate Village Water and Sanitation Committee by involving the village Priests and Maulvis;
- 27) Ensure hand pumps in every hamlet as per the Government norms;
- 28) Contaminated water sources must be tested and marked dangerous and alternative arrangement of drinking water must be made;
- 29) Shankargarh block is found to be having water shortage and maximum number of contaminated water sources. Special drive must be carried out to provide alternative safe drinking water facilities under various Government schemes like Swajaldhara, etc.;
- 30) To make the District a pollution-free, particularly the Shankargarh block, due to quarries and mines, the District administration must issue appropriate directions to the companies to decrease the pollution as per norms and also ensure that the brick kilns are issued license and they operate in the allocated places;
- 31) District administration shall furnish a report within two weeks on the immunization/ vaccination, growth chart, figure on malnourishment (grade-wise) and measures to deal with the malnourishment;
- 32) It may share the proposal sent to the central ministries for new building for the homes, Nutrition Rehabilitation Centres, etc. with the Commission for follow-up at central level;
- 33) Must ensure inter-departmental/agency coordination and proper conversion of schemes, such as the facilities like health, education, housing and social security available for the Bidi workers;
- 34) It must evolve its own action plan on health, education and other development issues and ensure on priority basis that each District is having its own children home as required under the J.J. Act;
- 35) Furnish a report on Infant Mortality and Maternal Mortality to the Commission within 15 days;
- 36) Ensure coordination between Childline, police and CWC to safeguard the rights of the children;
- 37) Conduct training programme for the District officials to sensitize them on child rights issues and schemes;
- 38) Strengthen Special Juvenile Police Unit as per Juvenile Justice Act; and

- 39) Non-Governmental Organisations (NGOs) must be roped-in in all the development programs as handholding and towards transparency.

The Commission solicited early implementation of the above recommendations and an Action Taken Report from the State Government/ District Administration at the earliest.

The National Commission for Protection of Child Rights (NCPCR), has been constituted by the Ministry of Women & Child Development as a Statutory Body of Government of India under Section 3 of the Commissions for Protection of Child Rights (CPCR) Act, 2005 to exercise the powers conferred on and to perform the functions assigned to it under this Act.

2. One of the functions of the Commission under Section 13(1) (j) of the CPCR Act, 2005, is to inquire into the complaints and to take suo motto notice of the violations/deprivations of child rights.

3. The Commission, under Section 14 of the CPCR Act, 2005, has all the powers of a Civil Court in trying a suit under the Code of Civil Procedure, 1908 (5 of 1908) and, in particular, in respect of the following matters:

- a) Summoning and enforcing the attendance of any person and examining him on oath;
- b) Discovery and production of any document;
- c) Receiving evidence on affidavits;
- d) Requisitioning any public record or copy thereof from any court or office; and
- e) Issuing commissions for the examination of witnesses or documents;

4. *Dr. Yogesh Dube, Member, NCPCR cum Chairman, Core Committee on Child Rights, Uttar Pradesh will be visiting Allahabad to investigate the complaint of rape cases in Children Observation Home at Allahabad, as published in the news papers, review the petition filed by the Commission in Allahabad High Court in the case of a juvenile Raj Sharma and to meet with*


